## **WORKSHOPS AND PROGRAMS**

**9:45 AM. “An Old Timer and his Clock Collecting.”** John Fitzwilliam, now an NAWCC “Old Timer,” looks back over the years since acquiring his first clocks in the late 1950’s. What inspired him and others to pursue vintage clocks, and how such pieces have fared in the collectors’ market? And the amazing diversity of timekeepers one can collect. John was brought up in the Boston suburb of Wellesley, surrounded by neighbors with antique clocks. A memorable childhood visit to Old Sturbridge Village’s clock collection also prompted his fascination with them. A part-time job at Spivack Antiques in Wellesley, and a stint with David G. Hills, also a Wellesley native and owner of a high-end clock shop there, inspired John to start a clock business in neighboring Newton Upper Falls in 1975.

**10:45 AM. Horology in Art Symposium Recap.”** Many of the 120 participants and speakers at the October Museum of Fine Arts NAWCC symposium stated that this conference was the best they ever attended. With many images and video clips, Symposium organizer **Bob Frishman** will present an illustrated summary of the groundbreaking event. Sixteen presenters including art history and horology professors, curators and experts all gave important lectures which Bob will highlight. A Chapter 8 Past-President, Bob has been a working horologist and scholar for nearly four decades. He is an NAWCC Fellow and Time Symposium Committee Chairman, and a Freeman of the Worshipful Company of Clockmakers. ### **12:00 PM. Lunch and annual after-lunch chapter 8 business meeting and discussion**

Amongst the regular business matters, we have one change each to make to the constitution and the by-laws that require a two-thirds vote by the meeting attendees:

Chapter 8 constitution by-law change: allow all elected council positions to serve more than one term. The President suggested the following change to Article 1, Section 2, Terms of Office. This change will be to eliminate the sentence that reads, "Terms of office for Officers shall be one term in that office, except that a member may serve as Second Vice President, Secretary or Treasurer for an indefinite number of terms and may be re-elected immediately." A council motion was made and accepted.

Chapter 8 constitution article change: allow the council to have at least six Directors. The President suggested the following change to Article V, Council. The change will be to change the wording of the sentence that reads, "There shall be six Directors ...," to "There shall be at least six Directors ..." A council motion was made and accepted.

### **DIRECTIONS:**

From the East or West: Mass Turnpike (I-90), take Exit 10, then stay to the right after exiting the toll plaza and to Southbridge St. (Route 12) going south. The Elks Club is about 0.6 mile on the right. Watch for the sign.

From the North: follow Route 290 to Exit 6, then to Route 20 West. Follow Route 20 to the 4<sup>th</sup> set of lights (Route 12 intersection). Turn right (north) on to Route 12. The Elks Club is about 0.3 mile on the left. Watch for the sign. Note: the exit for Route 20 West off of Route 290 in the very first exit after the Mass Turnpike. The exit comes up quickly, so be aware of this situation.

From the South: follow Route 395 (becomes Route 290 in Auburn) and take Exit 6 for Route 20 West. Proceed to the 4<sup>th</sup> set of lights (the junction of Routes 12 and 20) and turn right on to Route 12 North. The Elks Club is about 0.3 mile on the left. Watch for the sign.
